Many of the older models produced in the 1950s and 60s are still in use today and require increased service to maintain their performance. While this is a tribute to the product's quality, many of these old depositories, along with several competitors' units, are beginning to fail on a regular basis, and it can be a challenge to find available replacement parts.

Many older depositories can experience a serious malfunction that could result in lost or unaccounted for deposits. Over time, gaps begin to widen, allowing deposits to slip into areas where they may remain undetected. These failures cause disruptions to financial institutions and consumers, and require expensive service calls to repair the unit. Eventually, the AHD will wear beyond repair and the entire unit will need to be replaced.

## REPLACING AN EXISTING AHD WITH A RETROFIT KIT

- AHD Head Retrofit Kits are designed to replace a specific AHD head.
  The new replacement AHD size and appearance will vary by kit based on the AHD head being replaced
- Kit includes AHD head replacement only, the chute and/or safe is not included.
- The minimum safe door opening is 24"W x 24"H for physical access to the safe (site survey required)
- The chute length must be 12" or less for reach into the chute (site survey required)
- The Americans with Disabilities Act (ADA) provides guidance whenever there are modifications made to an After-Hour Depository.
   Therefore, the push/pull force must be five pounds or less with a 48" maximum reach

- The AHD retrofit kit head is ADA compliant regarding the 5lb pull and push. When replacing an existing head, the height may or may not be compliant. If necessary, compliance can be achieved by reducing the height in order to lower the housing
- Each kit includes installation instructions specific to the AHD head being replaced
- None of the retrofit kit AHD heads are equipped with lights or envelop holders
